### **Resolutions adopted by the Ordinary General Assembly of INPRO S.A. on 28 June 2021**

The Management Board of INPRO S.A. (the "Company") with its registered office in Gdańsk hereby presents the wording of the resolutions (with appendices) adopted by the Ordinary General Assembly of the Company on 28 June 2021 with the indication, with each of the resolutions adopted, of the number of shares under which valid votes were cast, the percentage of those shares in the share capital and the total number of valid votes, including "in favour," "against" and "abstaining."

The Ordinary General Meeting of the Company did not waive the consideration of any item on the agenda. No objections were made against any of the resolutions covered by the minutes of the General Meeting. All the resolutions put to the vote were adopted.
